We invite you to join us on one of our amazing journeys and kick off the next 20 years of adventure!

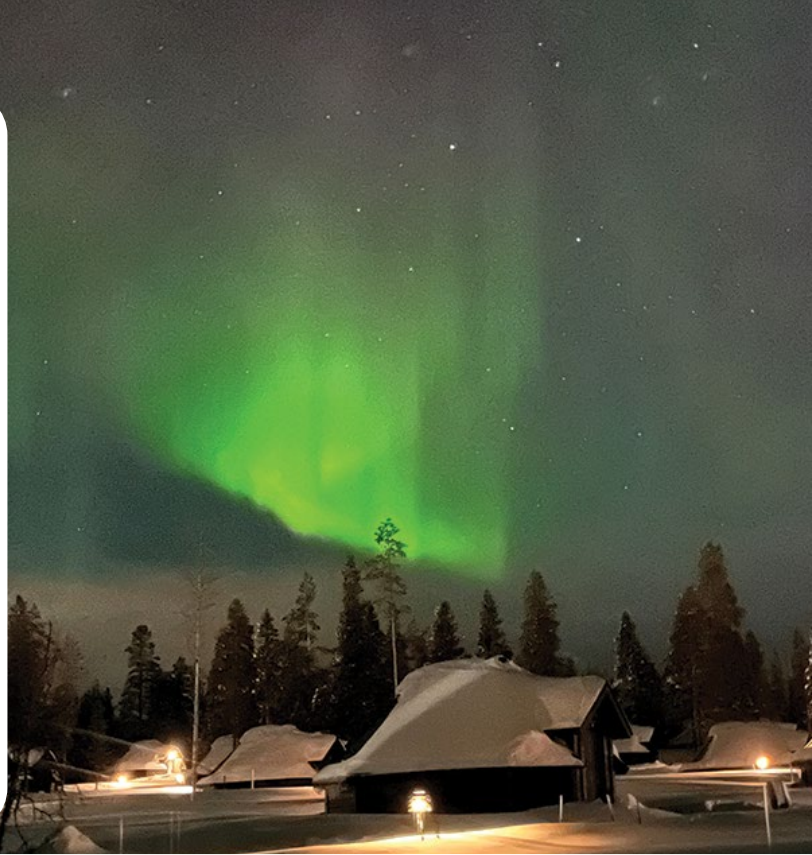

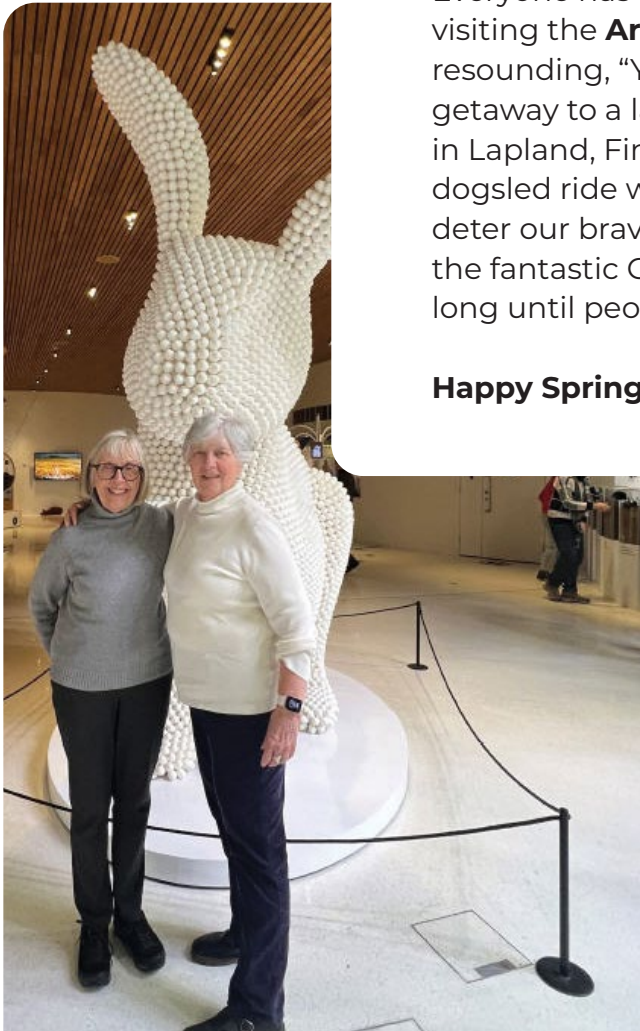
